2.	Composition / Indications to components	<p>Chemical characterization: CAS No.: 9003-07-0</p>
3.	Possible dangers	<p>The melted product adheres to the skin and causes burning. Danger of slippery on spilt material. Possible production of electrostatic charging when used.</p> <p><b>Classification system</b> This material is not hazardous according to the wording of the directives EEC 88/379, 67/548 and subsequent amendments.</p>
4.	First-aid measures	<p><b>General information</b> At room temperature the product doesn't cause irritation nor give off dangerous gases/vapours. The measures listed below apply to critical situations (Fire, incorrect process conditions).</p> <p><b>After inhalation</b> In case of excessive inhalation of fumes bring the person into fresh air. Call for medical help. Keep person warm, if necessary give mouth to mouth resuscitation, or artificial respiration.</p> <p><b>After skin contact</b> After contact with hot product, cool rapidly with cold water.
